## TTBS appoints Paul Snape as National President



Paul Snape is the new TTBS National President

t the Timber Trades Benevolent Society's Annual General Meeting, held on Thursday 9th May at the Royal Air Force Club, Piccadilly, Paul Snape of WS Logistics Ltd was appointed as the National President for 2019 and 2020, succeeding Ivan Savage, who continues as the Society's General Manager.

Paul commenced his involvement with the timber industry with Henry Tyrer on 5th November 1973 at Seaforth Timber Terminal, which had only been open for about six weeks when he started. Seaforth Terminal handled all the western Canadian timber shipped by Seaboard International, a company long gone.

Seaforth Terminal also handled timber

cargoes from Russia for Bahr Behrend, another company now consigned to the history books.

In the late seventies, Liverpool started handling cargoes from the Far East, shipped by Ben Line Steamers and, at the time, Paul was working in the Liverpool head office and handling all the operation / distribution side for the Far East shipments. He still does this today, albeit everything is now in containers.

Henry Tyrer was taken over by the Harrison Line in 1998, but unfortunately by January of 2002 they went into liquidation. Paul was fortunate in that Pan Ocean Shipping of Korea, who he had looked after since the late eighties told Charles Gee, who subsequently took over their agency

business, that Paul was to be part of the package, so he retained his position doing what he had been doing for many years.

In late 2009 Paul was approached to set up an office for WS Logistics Ltd (www. wslogistics.com) in the Liverpool area, and in February 2010 the office was up and running. Here he continued to do what he had been doing successfully for over 36 years, handling timber and plywood cargoes from around the world.

Paul's connection with the Timber Trades Benevolent Society goes back to the early nineties when Henry Tyrer supported the Liverpool Christmas lunch by taking a table with customers and also with the annual dinner and dance events, taking tables for the staff who were involved in the timber side of the business.

Paul was approached by Mike Tattersall to join the Liverpool (now the North West) TTBS Committee in late 1997 and attended his first meeting in early 1998. As the North West Region was organising a centenary ball at St George's Hall that year, Paul got involved recruiting sponsors and also managed to obtain £5,000 to cover the cost of hiring the hall.

Since 1998, Paul has loyally striven on behalf of the North West Committee to gain financial support, something he very much enjoys and also finding the excellent entertainment acts for the North West functions.

Paul has also served as NW Region President in 1999 and again in 2002.

He will be supported during 2019 and 2020 by National Vice-President, John Taylor FCA, previously Chief Executive for Wyckham Blackwell Ltd, Hampton in Arden and also one of the current TTBS investment managers.

John has also been the Midlands Region TTBS Treasurer for a number of years and is currently the Midlands Vice-President.

#### **TTBS** beneficiary turns 100



On the 17th February this year, a special birthday celebration took place for one of the North East TTBS Region's long-standing beneficiaries.

Mrs Doreen Crosbie, having received her 100th birthday card from the Queen and many other cards from well-wishers, was treated to a party at the Racecourse Room, Grand Hotel, Gosforth Park, Newcastle upon Tyne, attended by her family and

Mrs Crosbie, who lives independently in the home she has occupied for 80 years, is still mobile and well supported by her family. She started life in service in a grand house in Jesmond, before signing up to the WAAF where she met her husband Jim. She was widowed in 1973. Mrs Crosbie's connection to the TTBS started soon after, when an advert placed by MH Southern & Co Ltd, who had previously purchased Clayton & Armstrong Ltd, caught the attention of her son-in-law Trevor, who was acquainted with Peter Southern through the Gosforth Rugby Club (now the Newcastle Falcons). Trevor mentioned that Jim had worked at Clayton & Armstrong and the North East TTBS Region were informed that Doreen might require some support.

Mrs Crosbie has been so grateful for the TTBS support, which of course is ongoing, so much so that she, her family and friends donated £500 to the TTBS in lieu of birthday presents on the day.


To date, player numbers are slightly lower than we would expect, so the Society is appealing for more industry golfers to apply for places.
